The Department of Ecology & Evolutionary Biology seeks one (1) Course Instructor for the following course:

EEB403H: Tropical Field Biology

Course description: A two-week field course offered in Peru, introducing students to the diversity of biological communities in the tropics focusing on ecological and evolutionary interactions. Plant and animal communities of the New World tropics are compared and contrasted with temperate communities. Student research projects included.

Estimate of the course enrolment: 20

Estimate of TA support: 0 hours

Class schedule: This course will take place in Peru for the duration of August 2-16, 2024. Transportation, meals and accommodations will be provided by the department for the duration of the travel period.

Sessional dates of appointment: August 1-31, 2024; pre-course meetings begin in late June 2024

Minimum Qualifications: Academic qualifications and suitability for this course. A strong background in tropical ecology and conservation biology. A good knowledge of the taxonomy, natural history, and ecology of tropical organisms.

Preferred Qualifications: Research experience (experimental or monitoring) with tropical organisms and fluency in Spanish is preferred. Past experience teaching this course or a similar university-level field course in the tropics is preferred.

Relevant Criterion: Past teaching experience is the more relevant criterion than the need to acquire experience in respect of these posted positions.

Description of the duties: Lead and/or design group teaching with EEB faculty members. Preparation and delivery of field activities; deliver impromptu and organized lectures on aspects of tropical ecology

and evolution; devise customized course content under dynamic field conditions related to their prior expertise; help advise, assist and supervise activities in the field including student research projects; unload equipment and set up teaching activities on site; available for office hours; assist to grade and comment on group and individual oral presentations as appropriate and in accordance with University regulations as described in the Faculty of Arts & Science Academic Handbook.

EEB325H1F: Evolutionary Medicine

Course description: How evolutionary principles can help us better understand health and disease. Concepts from evolutionary biology (e.g., life history theory, coevolution, genomic conflict, constraints and trade-offs) will be applied to key problems in medicine and public health, including antibiotic resistance, aging, cancer, autoimmune disease, and pathogen virulence.

Estimate of the course enrolment: 48

Estimate of TA support: 140 hours

Class schedule: Lectures – Tuesdays and Thursdays 10:00am-1:00pm; and Tutorials – Tuesdays and Thursdays 2:00pm-3:00pm

Sessional dates of appointment: May 1, 2024 to June 30, 2024

Minimum Qualifications: Academic background in the subject area and ability in teaching the course subject at a university level. A strong academic background in evolution of infectious diseases and/or human evolution; PhD in EEB; and demonstrated evidence of excellence in teaching at the university level.

Preferred Qualifications: Past experience teaching this course or a similar university-level course.

Relevant Criterion: Past teaching experience is the more relevant criterion than the need to acquire experience in respect of these posted positions.

Description of the duties: Prepare and deliver lectures and prepare tutorial activities; prepare syllabus and, train and supervise teaching assistant(s) assigned to the course; conduct office hours; preparation, supervision, and grading of tests, assignments, and examinations in accordance with University regulations as described in the Faculty of Arts & Science Academic Handbook.
